

# Nod for bills: SC reminds Guvs on 'ASAP' condition

SC says 'as soon as possible' has constitutional implications, functionaries must keep it in mind

IN the plea filed by the Telangana government seeking directions to Governor Tamilisai Soundararajan to clear the 10 Bills passed by the State Legislature, the Supreme Court on Monday said that the Governor should keep in mind the phrase "as soon as possible" while ex-

pressions, and must be borne in mind by all constitutional functionaries."

During the hearing, S-G Tushar Mehta informed the bench that there were no Bills pending as all had been assented to by the Governor.

The bench indicated its intention to dispose of the plea, but senior advocate Dushyant Dave, representing the Telangana government, urged the court to issue directions to resolve the issue once and for all. "Elected government is at the mercy of the governor. Your lordships may decide this once and for all. In Madhya Pradesh, Bills are being assented to within one week, (and) in Gujarat, within one month. Telangana is an opposition state and so this is happening," he said.

Dave had earlier highlighted the fact that the bills had been pending since September 2022, and argued that this sends a "very wrong message". He had pointed out that in Madhya Pradesh, bills are assented to within 7-10 days and questioned why the same could not be done in Telangana.



After being informed that all the pending bills had been assented to by the Governor, a bench, comprising Chief Justice of India DY Chandrachud and Justice PS Narasimha, stated in their order, "The communication dated April 23 from the Secretary to the Solicitor General (S-G) contains the status of the Bills pending. At this stage, we are not going into the merits of the case.

However, it is important to note that Article 200(1) of the Constitution and the word 'as soon as possible' have significant constitutional implications.

# Youth must join hands with BJP to transform KL: PM

While one ideology places their vested interests over the interests of the state, the other is working for a family. These two fronts have made Kerala a hub of corruption. It is time for the youth in Kerala to defeat these ideologies," he said.

Referring to the allegations of corruption against the LDF government, he said while the BJP government is striving to bring development to Kerala, some people in the state are smuggling gold.

"They are playing with the future of Kerala and the youth have understood this. The BJP

Expressing the hope that Kerala will embrace BJP in the immediate future, he said Kerala will follow the example of the Northeastern states and

Goa soon. "The states of the North East and Goa have understood the development agenda of BJP. I am sure that Kerala will also support BJP in future. This Union will transform Kerala's future. We have to change the destiny of Kerala. We will progress together," he said.

"The world believes that the 21st century is the century of India. The world is discussing Start-up India, Stand-Up India and Digital India. India is becoming self-reliant through Aatmanirbhar Bharat. There was a time when India was among the five most fragile economies, but now we are a fast-growing economy. # 14 TV channels may broadcast Chithirai fest

MADURAI: With the HR&CE department passing a new G.O. regarding the live broadcasting rights of the Chithirai festival, the decks have cleared for the spectacle to be telecast live on 14 media platforms.

Official sources said previously the broadcast rights were allocated through a tender process. The bidder which quotes the highest tender amount would receive the sole authorisation to broadcast the event live. With a view to allowing more platforms to air the content, the government has now passed the special G.O.

Firms that wish to broadcast the festival live had to submit a requisition order with the temple, and pay ₹40,000 for each hour of the live broadcast. An additional ₹40,000 as insurance per hour was also handed over. ENS

# SC quashes HC order shielding MP from arrest in Viveka murder case

THE Supreme Court on Monday set aside Telangana High Court order that had granted Kadapa MP Avinash Reddy interim protection from arrest and directed the Central Bureau of Investigation (CBI) to conduct the investigation as per law in former minister YS Vivekananda Reddy murder case.

The high court had directed the CBI to present its questionnaire in printed form and tape its interrogation of Avinash Reddy. Terming the high court order "premature", a bench of Chief Justice D Y Chandrachud and Justice P S Narasimha quashed the direction the HC had issued to the CBI.

The top court, however, said the high court can pro-

ceed with the hearing of the anticipatory bail plea of Avinash Reddy on merits.

The apex court observed that the high court had passed an extraordinary order by misapplying itself. The bench in its order said, "Such orders of the high court allow to prejudice the course of investigation, particularly at the stage, when CBI has to find the role of the accused. We are of the view that the directions issued by the court were unwarranted."

As the hearing drew to a close, CJI DY Chandrachud remarked that he was perturbed by the high court order. "This will stultify investigation. The high court cannot order an investigation of a suspect to be in written

form. If this is the standard for investigation, then it is better to wind up the CBI. Other accused will cite this as a precedent. First anticipatory bail and then questionnaire to CBI. This is like rewriting criminal law jurisprudence. At the end of it, CBI may or may not arrest you. If CBI had to arrest you, they would have done so earlier. CBI has shown utmost restraint."

The court refused to grant Avinash Reddy further protection from arrest, however, it directed CBI to complete its probe into the case by June 30. Earlier, the top court had slammed the CBI for its "lackadaisical" approach had asked it to wind up the case by April 30.

# Staff: Tangedco must fill field vacancies first

A field staff, K Ganeshan (name changed) in Coimbatore told TNIE, "TANGEDCO will be filling up 200 technical assistant posts through the Tamil Nadu Public Service Commission (TNPS). However, no steps were taken to fill posts of field staff. As there are no adequate staff in the section office, we are facing work burden in the field work and are affected both physically and mentally."
