

'First an athlete and then an administrator', IOA president 'stands' by wrestlers

Promise of support comes from Usha

New Delhi: IOA president PT Usha, after facing criticism from all quarters for being insensitive towards the protesting wrestlers, on Wednesday met the grapplers at the protest site and assured them of her support, saying she was first an athlete and then an administrator.

Former sprinter Usha had come down heavily on the wrestlers for resuming their protest instead of approaching the Indian Olympic Association (IOA) for their issues. She had said that the wrestlers should have shown some discipline and that they had tarnished the country's image by hitting the streets, a comment for which she and the IOA faced criticism.

Usha left without speaking to the media on Wednesday but Bajrang Punia said she was assured of their help.

"Initially when she said that, we felt very bad but then she said that her comments were misinterpreted. She said that she is first an athlete and then an administrator," said Bajrang, the Tokyo Games bronze medalist.

"We told her that we want justice. We don't have a fight with the government or opposition or anyone else. We are

sitting here for the betterment of wrestling. If this issue is resolved and if the allegations (against Wrestling Federation of India president Brijbhushan Sharan Singh) are proved then there should be legal action," he added.

When asked if Usha had come with a solution from the government or from the IOA, Punia said: "Nothing of that sort. She only said that she is with us."

Asked if he was satisfied following the meeting with Usha, he said: "If she is giving us assurance, I suppose she should fulfil that assurance. But we clarified to her that until we get justice, of which we are very hopeful, this pro-



The Supreme Court

New Delhi: The seven women wrestlers, who have levelled allegations of sexual harassment against Wrestling Federation of India (WFI) chief Brijbhushan Sharan Singh, on Wednesday moved the Supreme Court seeking permission to file an affidavit in a sealed cover.

On April 28, Delhi Police had filed two FIRs against Singh on the allegations of the wrestlers. It came hours after solicitor-general Tushar Mehta, appearing for Delhi Police, told the apex court that

a case will be registered that day itself.

On Wednesday, the counsel representing the women wrestlers mentioned the matter before a bench comprising Chief Justice D.Y. Chandrachud and Justice P.S. Narasimha and said he was seeking permission to file the affidavit in a sealed cover before the court.

The court is slated to hear the matter on Thursday.

The counsel said they don't have any problem supplying the copy of the affidavit to the solicitor-general but it should not go in the public domain. The bench permitted the counsel to bring the sealed cover affidavit on Thursday with an advance copy to Mehta and allowed Mehta to share the material with the investigation officer. PTI

World body asks for clarity

New Delhi: President of United World Wrestling (UWW) Nenad Lalovic, "concerned" with the turmoil in the Indian wrestling fraternity, has demanded clarity on who is running the sport in the country.

In his response, the Wrestling Federation of India (WFI) has complained of "aggravate interference" in their matters.

Lalovic had written a letter to the WFI on April 28 in which he wrote: "It is not clear who exactly enters the athletes in the UWW events and who is in charge of the daily management of the federation."

"The information that UWW received from the media these days is that the investigation report on alleged harassment and abuse by Mr. (Brijbhushan Sharan Singh) has been finalised in early April and was forwarded to the Ministry of Sport," Lalovic

wrote in his letter. "To date, no other action has been taken and the wrestlers have resumed their sitting protest. In addition, the WFI has convened an election general assembly on 7 May 2023.

"I am very concerned about all this and I urge you to provide UWW with official and accurate information about the situation. We reserve the right to take measures in case of failure to do so," Lalovic's letter said.

The world body chief also wrote that, "UWW usually appoints an observer to national federations' elections when particular situations warrant it."

"This is the case with the WFI and we would be glad to be informed about the status of this matter so we can make the necessary arrangements." PTI
